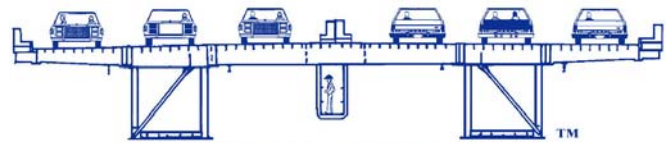

Draft paper due July 15, 2004

Final paper due October 15, 2004

Your manuscript shall be prepared in accordance with ASCE CD-ROM Proceedings: *Preparation of Manuscript*, which can be found on [www.pubs.asce.org/authors/cdmsprep.pdf](http://www.pubs.asce.org/authors/cdmsprep.pdf).

The preferred format for author's papers is a pdf file e-mailed to [asce@asce-sacto.org](mailto:asce@asce-sacto.org). Alternatively, manuscripts should be printed on plain white paper, preferably by a laser printer. No special paper will be provided for the final camera-ready copy. Please limit the length of your paper to 12 pages, including figures and tables. All manuscripts, as well as questions on editorial content and deadlines, should be submitted to the ASCE, Sacramento Section address.
